Dear Minister Ehanire,

For the Fifth Replenishment of the Global Fund to Fight AIDS, Tuberculosis and Malaria (Global Fund) in 2016, Federal Republic of Nigeria pledged **USD 10,000,000** to the Global Fund for the 2017 – 2019 allocation cycle. Since the inception of Global Fund in 2002, Federal Republic of Nigeria has contributed **USD 28,624,253** to the Global Fund becoming one of the few implementing countries from the African Region which is also contributing to the fight against the three diseases through the Global Fund. The Global Fund Advocates Network Africa (GFAN Africa) and the Global Fund Advocates Network Asia-Pacific (GFAN AP), along with advocates, activists and representatives of communities living with, affected by, and/or vulnerable to the three diseases in Africa and Asia-Pacific appreciate the contributions from the Federal Republic of Nigeria to the Global Fund which has saved over 27 million lives and continue to build resilient and sustainable systems for health, promote and protect human rights, and advance gender equality.

We cannot get out of our minds how your contributions to the Global Fund have catalysed counterpart domestic resources contributions for health from other implementing countries. The continuous support that donors including yourself to the Global Fund, sends the message that you do care about us, the fight against the three diseases, and improving the lives of those most impacted and vulnerable to them!

On Saint Valentine's Day this year, GFAN Africa worked with communities and civil society to reach out to embassies in the Federal Republic of Nigeria of the Commonwealth of Australia, Kingdom of Belgium, Canada, People's Republic of China, Republic of Cote d'Ivoire, Kingdom of Denmark, European Commission, French Republic, Federal Republic of Germany, Republic of India, Ireland, Japan, Republic of Kenya, Republic of Korea, State of Kuwait, Grand Duchy of Luxemburg, Netherlands, New Zealand, Kingdom of Norway, Portuguese Republic, State of Qatar, State of Saudi Arabia, Republic of Senegal, Kingdom of Sweden, Swiss Confederation, Togolese Republic, Republic of Uganda, United Kingdom of Great Britain and Northern Ireland and United States of America with Saint Valentine's Day cards, love letters and flowers to appreciate their contributions to the Global Fund so far and to urge them to increase their pledges and calling them to #LoveMoreGiveMore for the Global Fund Sixth Replenishment.

This year, the Global Fund embarked on its Sixth Replenishment process to raise at least USD 14 billion which will help to save 16 million lives, cut the mortality rate from HIV, TB and malaria in half, and contribute towards stronger health systems by 2023. Technical partners have estimated the total funding need for AIDS, TB and malaria at USD 46 billion annually of which, as the Get Back on Track to

End the Epidemics report¹ by the Global Fund Advocates Network (GFAN) estimates, at least USD 16.8 to USD 18 billion should be invested through the Global Fund for the Sixth Replenishment (2020-2022).

To get back on track for the fight against the three diseases we need to step up total funding to at least USD 83 billion for the next three-year cycle for 2020 – 2022, an increase of USD 17 billion where most of the increase will come from increased domestic funding.

The Global Fund's Investment Case for the Sixth Replenishment projects that domestic funding for programmes to fight HIV, TB and malaria over the period 2020 – 2022 will grow to USD 46 billion, an increase of 48 percent over the current cycle. As such, it is crucial that national governments take proactive steps towards sustainably increasing domestic resources for health and towards the three diseases. This also means taking concrete steps towards fulfilling the commitment of the Abuja declaration on allocating at least 15% of the annual national budget to improve the health sector.

Encouraging and stimulating domestic investments in health is an essential component of the Global Fund's move towards sustainable health programmes in all the countries where the partnership invests and its Sustainability, Transition and Co-Financing Policy² aims to support countries as they move towards domestically funded systems for health and responses to HIV, TB and malaria through providing tools to engage new partners and funding sources within the country with a goal of creating broader opportunities for fundraising.

In 2015, World Leaders committed to achieve the Sustainable Development Goals (SDGs) by 2030, pledging to deliver health and well-being for all, to achieve Universal Health Coverage (UHC), and to build a more prosperous, equitable and sustainable world by leaving no one behind. In 2018, the development of the Global Action Plan and its framework united 12 health and development institutions under a common aim to accelerate progress towards SDG 3: Health and Well-being for all. With only 11 years more to 2030, it is crucial that we accelerate our actions in achieving SDGs.

Raising at least USD 14 billion for the Global Fund Sixth Replenishment will present us with an opportunity towards the acceleration of progress towards SDG 3 and UHC through strengthening systems for health; reinforcing health security; spurring domestic investment of USD 46 billion during the period 2021-2023; tackling inequalities in health including gender- and human rights-related barriers to access; and yielding a return on investment of 1:19 with every dollar invested.

Getting back on track to end the epidemics and delivering the broader SDG 3 targets will require all the actors involved, including multilateral and bilateral partners, governments, communities, civil society, and the private sector to raise their game, accelerate innovation, coordinate and collaborate more efficiently and execute programmes more effectively.

An increased and successful Replenishment will provide the Global Fund the ability to scale up its effective responses and get the world back on track to fight the three diseases!

Hence, we³ want you to be our Hero!

Be a Global Fund Sixth Replenishment Hero and show us you care by increasing your Pledge to the Sixth Replenishment of the Global Fund from your previous pledge for the Fifth Replenishment!
